

REACH ROHS CONFLICT MINERALS

Dear Sir/Madam

The Stén Group consists of Sten Steel and Kimet Oy, which operate as import and wholesalers of high-quality steel and aluminium products. Stén Group companies are bound by the European Union's REACH (EC 1907/2006), RoHS (2011/65/EU) and conflict mineral regulations. The core values of the group's companies include acting as reliable and expert partners for their clients and other stakeholders.

Steel and aluminium products imported and sold by the Stén Group are categorised as objects according to the REACH regulation. However, the products sold by the group do not need to be registered, because they do not release any substances under normal or reasonably foreseeable conditions of use. As wholesalers, the group companies cannot influence the manufacturing processes of the steel and aluminium products in any way. As a result, in order to make sure that the products they import are in compliance with the regulations, the group companies have carefully evaluated the activities of their suppliers in this regard and received written confirmation from most of their suppliers that the delivered steel and aluminium products are in compliance with the regulations.

The companies within the Stén Group constantly monitor the Candidate List of Substance of Very High Concern (SVHC) and inform their clients if any substances appearing on the Candidate List that are present in the products sold by the group companies. Sten Steel and Kimet Oy have prepared notifications for the SCIP database regarding the following steel grades containing a concentration of more than 0.1 % by weight of a substance within the SVHC Candidate List:

Sten Steel operates as an importer of metal injection powders referred to in the REACH regulation. However, the total amount of the substance imported by the company is less than 1 ton annually. Sten Steel submits safety data sheets for imported substances to its clients.

In summary, Sten Steel and Kimet Oy state that they have taken all reasonably necessary and available measures to ensure that the products they import are in compliance with REACH, RoHS and the conflict minerals regulation. Currently, the products sold by Sten Steel and Kimet Oy comply with the REACH and conflict minerals regulations as confirmed by the suppliers of the steel and aluminum products. Regarding compliance with the RoHS regulation, Sten Steel and Kimet Oy provide their clients a separate certificate for the product upon a request.
